

## **We Value Your Privacy**

It is the goal of Vaulting Systems International to protect your privacy. The following is a summary of the various ways we treat the information you provide us while using this site.

### **The type of information Vaulting Systems International collects**

Vaulting Systems International generally collects personally identifying information with your specific knowledge and consent. For example, when you make a purchase or register to use our services, you are asked to provide information, such as your e-mail address, name or phone number.

### **How Vaulting Systems International uses information provided by you**

Vaulting Systems International uses this information to provide you with the services you have requested. For example, if you purchase any of our services, we may use your e-mail address to send you a confirmation or payment due notice and your mailing address to send you merchandise. We may also use the information to communicate with you about new features, products or services.

Vaulting Systems International does not sell your e-mail address to anyone. We do not share information with our affiliates. If you do not wish to receive communications from us about new features, products or services simply follow the unsubscribe instructions contained with the e-mail. If you have purchased a subscription to Estate<sup>++</sup>, you may also change or update information within your account.

If you choose to purchase services through our site from any of our affiliates any information you provide about yourself to them is subject to the affiliated service's privacy policy and not ours.

Your privacy is guaranteed in case of an emergency. As soon as we are notified of your death or incapacity your account will be locked. Your data can no longer be changed in any way. This action prevents unwanted changes to your data by others you have allowed to access your account.

You are responsible for changes to your information or to the revocation or replacement of your legal document(s). You understand that Estate<sup>++</sup> and Vaulting Systems International do not provide medical, legal, or financial advice, and that you may cancel this service at any time.

### **Security You Can Trust**

All of your sensitive personal information and documents are encrypted. Estate<sup>++</sup> employs a double encryption standard where data is encrypted in transmission ("in-flight") and in storage ("at-rest"). Even though Estate<sup>++</sup> is not a medical data application, it was designed to meet HIPAA's privacy and security standards for protected health information (PHI). Your data is stored in the same secure data storage infrastructure that Amazon.com uses to run its own global network of web sites.

### **For Your Eyes Only**

Only you have access to the information stored in Estate<sup>++</sup>. Our customer service representatives cannot view, move, download, add, update, or delete any of your information.

### **Telephone Numbers**

Our phone verification service sends one-time passwords to your cell phone in the form of a text message. When you opt-in for this service we require that you provide a valid cell phone number. This phone number is treated as confidential information and will not be used for any other purpose.

### **Cookies**

Cookies are pieces of information that are placed by a Web site in a storage place on your own computer. We use cookies to control browser session information in an encrypted format. This cookie is deleted when you logout or terminate your browser session. We do not use cookies to control the display content on our site or to personalize information. Some of our advertisers occasionally serve you cookies as well. We do not have control over cookies placed by advertisers.

If you don't want cookies, your Web browser likely includes an option that allows you to not accept them. However, if you set your browser to refuse cookies, Estate<sup>++</sup> may not function properly.

While your individual information is protected as outlined above, we reserve the right to use aggregated anonymous data about our users as a group for any business purpose, such as analyzing usage trends and seeking compatible advertisers and partners.

### **IP Address**

Your IP ("Internet Protocol") address is usually associated with the location from which you enter the Internet, most likely your Internet Service Provider. We may use your IP address to help diagnose problems with our server and administer our Web site. Your IP Address will never be used for any other purpose.

### **Kids and Parents**

Estate<sup>++</sup> is not intended for use by children, especially those under age 18. No one under age 18 is allowed to provide any personal information.
